

## Scotland + Venice 2023 - Submission

The submission is required to be of a quality to indicate that the project will stand out on a world stage in the competitive and crowded setting of the Biennale. As the project is aimed at a broad audience the narrative approach must be delivered in an imaginative and accessible manner and the content, design and graphics must reflect this while making the subject stimulating and interesting. The creative team should consider communication channels and methods that can be deployed to reach these diverse audiences.

Submissions are sought from a creative team which can provide the full range of skills required to cover all aspects of the project from curation, content development, design, design, production, presentations, activities, overall project management and the Professional Development Programme.

### Process

The process is a two-stages:

Stage 1: Proposals to be submitted via Public Contracts Scotland Website by **noon Monday 15 August 2022.** 

Shortlisted candidates informed by 19 August 2022.

Stage 2: Shortlisted candidates will be asked to present and clarify the proposals at the Selection Panel interviews on **24 August 2022.** 

## **Selection Panel**

The Selection Panel will represent the Scotland + Venice Partnership along with representatives from industry.

#### **Submission Requirements**

Item	Specification (all submissions shall be in PDF format)
Application Form	Written response to brief completed in full and signed by team lead
Concept Images	Images illustrating proposal (maximum 6 sides x A3)
Sample of writing	PDF of article or introduction text from previous exhibition /programme or blog post (maximum 2 sides x A4)
Previous work	Images of relevant previous projects (maximum 3 sides x A3
Budget Breakdown	Outline budget breakdown including all team fees, materials and production costs, any equipment required etc
Biographies/ CV	Maximum 1 side x A4 per team member

The overall submission should not exceed a maximum of 10 A3 sheets and a maximum of 2000 words.

## Submission/ Invitation to Tender

The Invitation to Tender (ITT) must be completed and returned electronically through the Public Contracts Scotland portal. No hard copies will be accepted. Large electronic files may take time to download, and tenderers should ensure that sufficient time is allowed for this to be done. The speed with which submissions are made is dependent on the size of the document - the maximum that can be uploaded to PCS per bid is 100Mb. Tenders are to be submitted in Microsoft Office Word or PDF format through the Public Contract Scotland website - the maximum that can be uploaded to the Public Contract Scotland portal.

All submitted documents should be in English and clearly labelled with the team lead's name.

The email submission, including all attached documents, must be a maximum of 5MB by **noon Monday 15 August 2022**.

Any questions regarding the tender can be submitted via the Public Contacts Scotland portal by **noon on 3 August 2022.** All questions and answers will be shared with all parties who have submitted notes of interest.
